-In order to retain the scholarship the student must successfully complete the program and maintain satisfactory academic progress

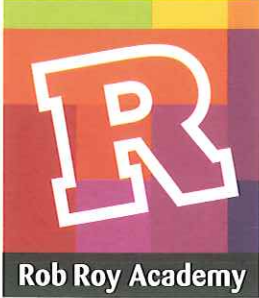
